ORDERING, DEPOSITS, ESCROW ACCOUNTS, DEALERSHIPS

ORDERING: Direct all sales inquiries and orders to delahayeusasales@hotmail.com. This includes all orders for bodies as well as ROADSTER SHOP BELLA FIGURA chassis and turnkey builds. Please initiate all orders via this e-mail address rather than calling on the telephone. Order forms should be faxed to us at 00 + 1 + 908 876 1692, or sent by e-mail to the above address, or postal mailed to DELAHAYE USA, P.O. Box G, 14 Schooley's Mountain Rd., Long Valley, NJ 07853 USA. Once we have received your signed ORDER FORM we will contact you confirming receipt of your Form and we will send you wire transfer information for your deposit, as well as a far more detailed order form itemizing options for body and chassis. A wire transfer is the preferred method of payment. At that time we will also require a signed and notarized form of ours regarding honoring our design patent and holding DELAHAYE USA and all of our vendors harmless from any and all product liability claims.

DEPOSITS, ESCROW ACCOUNTS: A 50% deposit is required on all body orders. A \$50,000 deposit is required on all Turnkey and aluminum body orders. All deposits will go into an escrow account and remain untouched until we are ready to begin construction on your car. At that time we will contact you to finalize and confirm your order and get your confirmation to proceed. Up until that point all deposits are fully refundable. However once construction on your body or car begins, because each car is a special order, it is the buyer's responsibility to pay for the completed car or body. While we do accept all major credit cards in our business, on any deposit exceeding \$5,000 we prefer wire transfers.

DETAILED ORDER: It is not necessary to list your full required specification when you make your initial deposit. You will receive a highly detailed order sheet on which to list your options, paint colors, interior trim selections and much more.

DEALERSHIP OPPORTUNITIES: We periodically received requests for being a dealer for our product. To qualify as a dealer you must buy three cars or body packages from us the first year, and one every year thereafter. First car ordered is at full price. Second and third receive a discount. Exclusive territories inside the USA or by country outside the USA are open for negotiation. At this time we are not dealership oriented as we're concentrating on getting into production.

SHIPPING, CRATING, TAXES, IMPORT DUTIES, ETC.

SHIPPING: Unless otherwise noted, composite body is f.o.b. Fort Wayne, IN. Alloy bodies are f.o.b. the panel beater's shop used. Polished alloy bodies will be made in UK. Customer arranges shipping of body or chassis wherever needed. For shipping large items (bodies, etc) OTR or by rail inside the USA we suggest you contact www.redhawkglobal.com in Ohio as we have used them many times domestically and were always satisfied with their prices and service. There may be additional shipping charges to a customer to deliver any optional parts (i.e. AC unit, steering column, brake and clutch pedals and master cylinders, etc.) from supplier to Fort Wayne, IN. However we will pay shipping from the supplier to Fort Wayne, IN on all

parts included in the aluminum or composite package listed on our web site. All parts shipping costs are at cost, i.e., we do not mark up shipping\.

MOUNTING BODY ON ROLLING CHASSIS: Not included in body package price. We can do this for you, but price to be determined.

CRATING BODY FOR SHIPPING: If necessary, we can crate and load bodies and chassis. Price to be determined, but reasonable. If possible, we suggest customer arranges to pick up body and/or chassis at Fort Wayne, IN.

TAXES: We will pay the taxes on all parts offered in our body package. Some optional parts (to be determined) may or may not include taxes from suppliers to deliver to Fort Wayne, IN where bodies are made, and in those instances the customer is responsible for the taxes. To our knowledge the only time we will charge a customer taxes (7%) on a car or body is if the car is delivered to New Jersey, since we are a New Jersey Corporation. There is an 8% Illinois state sales tax if you pick up the car or chassis at THE ROADSTER SHOP. There is no Illinois Tax if the chassis or car is shipped from ROADSTER SHOP to a destination outside of IL. No tax on labor.

EXPORT/IMPORT/DUTIES: Customer agrees to investigate and arrange everything relating to transporting cars, frame or body outside of the USA. We are investigating things such as bringing in unassembled components into South Africa allows you to avoid a high, almost 70% tax levied on a completed car.

Therefore it is agreed that the following, as well as the purchase price agreed upon, are conditions accepted in the purchase of your body and its components.

- (1) You shall not duplicate said vehicle or its components or allow anyone else to do so directly or indirectly.
- (2) In the event of such duplication through your agency, action or inaction, Appleton Productions Inc. shall have the option of either accepting \$50,000 per vehicle duplicated as liquidated damages, or in the alternative applying to the appropriate court of jurisdiction for equitable relief restraining and duplication no matter where said duplication occurred, whether it be in the continental USA or in a foreign country.
- (3) You agree that this agreement shall be interpreted according to the laws of New Jersey and agree to submit any disputes arising from this agreement to the Courts of the State of New Jersey.
- (4) In the event Appleton Productions Inc. incurs any legal fees necessitated by the enforcement of this agreement, said fees shall be paid by purchaser.

Appleton Productions Inc and DELAHAYE USA assumes no responsibility for the proper and safe assembly of the motor vehicle and components purchased. Purchaser assumes all risks in the assembly of said vehicle as well as its compliance with Local, State and Federal regulation and requirements. Purchaser shall hold harmless, indemnify or reimburse Appleton Production Inc. and DELAHAYE USA for any losses incurred as a result of the assembly and use of said vehicle or its components.
